Minutes of the meeting of Little Abington Parish Council held by videoconference on Monday 22 February 2021 at 7.15 pm

1. Apologies for absence. None.

The Chairman agreed to change the agenda to take public participation first.

5. Public Participation.

Abington Woods. There was strong support for the work and activities that take place on Abington Woods however there was some concern about the arrival of building and other materials and several storage containers over the last few weeks. The increasing unkempt appearance of the site, which is a Local Green Space, was a concern. The member of the public suggested a site visit. The school is planning a Health & Safety visit. The Chairman agreed to follow this up.

2. Minutes of last meeting.

The minutes of the Parish Council meeting held on 25 January 2021 were agreed with the following changes:

- Item 8: add "use of Speedwatch equipment".
- Item 9 The proposed Bourn Bridge Road cycleway route is on the road not the fields.
- Item 11 Typographical error A1307

3. Matters arising.

The action list was reviewed and updated. (See appendix).

- PRVs on Bourn Bridge Rd site visit follow up. Temporary signs have been erected, pedestrian traffic has reduced. The verge is starting to recover. The Clerk asked the County Council for more PRV marker discs. RS proposed that the Parish Council should consider permanent signage. The quote was £55.00 per sign. (c/f).
 CLERK to ask Highways about erecting "Pedestrians in road" signs.
- 4. Members' declarations of interests for items on the agenda. None.

6. Report from Clirs John and Henry Batchelor

The content of the report was noted.

Cambridgeshire County Council

- **COVID-19 Vaccinations.** Excellent progress is being made locally. Anyone aged over 70 who has not been contacted should get in touch with the local centre.
- **Elections.** Elections for the County Council, Cambridgeshire & Peterborough Combined Authority and the Police & Crime Commissioner will go ahead in May. Postal voting is an option.
- **Greater Cambridge Partnership- A1307.** Installation of average speed cameras between Haverhill and Linton has been delayed until April.
- 2021-22 Budget . A 3.99% increase has been agreed.
- Cambridgeshire Local. This initiative aims to build community cohesion and partnership working with the County Council.

South Cambs District Council

• Budget. SCDC to vote on an increase of £5:00 per annum for a band D property.

- COVID. Incidence in South Cambs has reduced to 77/100,000. Hospital
 admissions for COVID are falling but bed capacity is very stretched and the ICU is
 still full.
- Local Plan. There are many more sites in the mix than required to fulfil housing targets. There have already been several developments nearby JB recommended replying to the local survey. "Landscape intrusion" might be a consideration in rural areas. New transport corridors are likely candidates for development.

Cllrs Batchelor left the meeting at 20.05 pm.

- 7.1 Planning applications. Nil
- 7.2 Planning decisions
- S/3921/19/FL. Bancroft Farm, Church Lane. Erection of 6 dwellings, change of use & conversion of 2 agricultural barns to office space. Refused by SCDC Planning Committee. Appeal is possible. LAPC can register to participate. There was some concern about spreading "dereliction" on the site.
- **20/04982/HFUL. 15 Bourn Bridge Rd.** First floor rear extension & single storey side extension with internal alterations. Agreed by SCDC.
- 20/04343/HFUL. 30A Church Lane. Single storey front extension. SCDC Agreed.

- Greater Cambridge Local Plan Survey on sites: Closing date 1 March.
- Each parish councillor to draft a response for one of the sites in the locality.**ALL**
- **SB** to liaise with GAPC about sites in their area.

- Anthony Browne MP is seeking views on the proposed level of housing development in S Cambs
- Greater Cambridge Housing Strategy Consultation: No response required
- County Council Consultation: Local validation checklists. No response required.
- Uttlesford Local Plan. Consultation on Chapter 6 on Biodiversity has been launched. There are 9 themes. Some would not have any impact on the Abingtons. CLERK to send the list. Consultation for all themes closes on 21 April. (c/f)
- SCDC Planning Training. RA & SB attended .It was a useful session. SCDC was clearly endeavouring to improve engagement with parish councils. Quarterly sessions are planned. Presentation slides awaited.

8. Highways and traffic

- Local Highways Improvement application. VVA presented at the panel on behalf of LAPC. Cllr Henry Batchelor spoke in support. A decision is expected in June.
- Haverhill to Cambridge Rail Link. There were several advantages but it would be difficult to complete and maybe not cost effective. LAPC did not wish to reply.

9. Village Environment/Community Engagement

- Improving Broadband Gigabit Voucher Scheme. There have been 25 replies to date. RS has registered interest on behalf of both parish councils. It is not clear what level of support is required to make a scheme viable. Options for more publicity: Love Abington to their e-mail list, flyers in A&H News or newspapers.
- **Abington Directory**. Almost ready for printing. Better Broadband flyers could be included depending on publication date.
- **Coronavirus**. It was agreed to publish the South Cambs data dashboard on the Parish Council noticeboard every week. **SP.** Link on the Abington website **PB**.
- Love Abington. The Clerk is in regular contact. She also sends updates on grants. They have taken up the offer of a place on the MIND Mental Health training. Progress on establishing governance arrangements is not known. They have an open invitation to attend LAPC meetings.
- Litter. A Springtime Litter Pick will not be possible. Some residents pick up litter regularly Equipment including black bags is available on loan from the Clerk. Litter

accumulates around Fourwentways. Although litter picking is a planning condition SCDC Enforcement pay little attention. **SP** offered to tidy up the area under the underpass on the A505 in Pampisford.

- Abington Woods Discussed under public participation. It was agreed another visit would be helpful. An invitation might be required.
- Rural Community Energy Fund. Solar powered lights at bus stops. CLERK

10. Finance and Compliance

10.1 Finance report and balances

- The M10 report and summary was noted. There were some variances against the budget plan. The Clerk's hours are higher than planned.
- The projected year end position was presented. Income and expenditure would both be less than £25,000 so LAPC could be exempt from external audit. It must comply with the Transparency Code for Smaller Authorities.
