A Parish Council meeting was held on Monday on **Monday 2nd December 2019**, in the meeting room hall at the Institute.

Present: Jane Bowen, Tony Orgee, Pennie Zimmern, Liz Sainsbury, Emma Pery, the Clerk and two members of the public.

Meeting started at 7.30pm

76. Open Forum- A member of the public asked when the planning application submitted for 7A Chalky Road would be considered. Tony Orgee explained that the planning meeting would be advertised three working day before the application was to be considered; but the plans had not been received by the Clerk yet.

77. Apologies for absence – Bernie Talbot, Louise Patten

78. Planning application to be considered at the meeting:

A member of the public was given the opportunity to express his views on the planning application below before the council started to consider it. Mr Mark Carter explained that his bungalow at the rear of the planning application house, had both his living room and his master bedroom facing the site; both rooms would be overlooked by the proposed dormer which would lead to a loss of privacy. The dormer window would be replacing a fixed velux window.

S/3715/19/FL 33A Magna Close, Great Abington, Cambridge, CB21 6AF - rear dormer extension Pennie Zimmern highlighted that the application said both windows would be fitted with obscured glass and would only open in a limited way.

The original application S/3371/16/FL was approved on appeal with condition 7 was that the dwelling was a dwelling with no windows above ground level. It was noted that the plans did not show the existing 2 windows in the roof-line facing the Carter's garden, only one was on the plan. Councillors mentioned that the site seems over-developed and that an additional bedroom could make the existing parking problem even worse. Having living space upstairs was contrary to the original planning permission for a bungalow and would create a five bedroomed house. This application would give extra height to the development.

Councillors recommended that the application be refused, by a proposal from Jane Bowen which was seconded by Louise Patten, and supported by all councilors.

Member of the public left the meeting.

79. Update on Wellcome Trust Genome Campus planning application.

Tony Orgee advised the meeting that the District Council had approved application which would be considered by the Secretary of State, as requested by Hinxton Parish Council.
